We looked through the documents you sent us. A few items appear worth checking before anything is filed or signed, so we listed them below in the order that may be most helpful.

Here are the items that may be worth checking before the documents are filed or signed:

1. The Supplemental Filing to Petition to Fix Residence and Notes to Be Cleared appears to say "IN FOR THE COUNTY OF KERN" in the court heading. The wording may be missing "AND," which could make the caption look incomplete. Please check whether the heading should be made consistent with the prior filed version.
2. The same supplemental filing appears to spell the branch name as "JUVENILLE JUSTICE CENTER." The other court documents use "JUVENILE JUSTICE CENTER." Please check the spelling before the document is filed or signed.
3. The supplemental filing is dated 09/06/2023 and appears substantially similar to the supplemental filing that was electronically filed on 09/11/2023. If the uploaded Word document is intended as a new filing in 2026, the packet may be clearer if the date, wording, and purpose are checked so an older filing is not unintentionally submitted again.
4. The supplemental filing states that copies of the Texas request are attached as Exhibit A, but the uploaded Word document itself does not appear to contain that exhibit. Please check whether Exhibit A should be attached to the filing packet or whether the exhibit reference should be changed.
5. The prior Texas request included in the September 2023 filed packet appears to use "8912 Tenderfoot Dr" on one page, while the California orders and the supplemental filing use "8912 Tenderfoot Lane." These may refer to the same intended address, but the street type may be worth checking for consistency if that exhibit will be reused.
6. The GC-090 Order Fixing Residence Outside the State of California appears to contain the hearing information and proposed terms, but the judge's signature and date areas appear blank. If this document is being relied on as an entered court order, please check whether a signed or filed copy exists and use the clearest version available.

- ☐ Correct "JUVENILE JUSTICE CENTER" if the intended branch name is "JUVENILE JUSTICE CENTER."
- ☐ Check whether the 09/06/2023 date and older supplemental-filing wording should be updated before any new filing.
- ☐ Attach the intended Exhibit A or revise the exhibit reference if no exhibit is being submitted.
- ☐ Check whether the Texas exhibit address should use "Tenderfoot Lane" instead of "Tenderfoot Dr."
- ☐ Check whether a signed or filed copy of the GC-090 order is available if the order will be relied on.
